Proof of Residence (Power, Cable, Utility Bill), A driver's license or ID is not proof of residence.

For the CERDEP Child Development Application, these additional items are required:
Medicaid Card (Active) or Eligibility for Free/Reduced Lunch (Income Tax Form, Pay Stub)
